At 7:00 p.m. the Business Meeting of the Pawling Joint Sewer Commission was called to order by Chairman Dan Peters with the Pledge of Allegiance.

**MOTIONED** by Chairman Peters to:

- Approve the December 2022 Business Meeting Minutes as presented.
- Approve the December 2022 Organizational Meeting as presented
- Approve the December 2022 Treasurer's Report as presented.
- Approve payment of the December 2022 Vouchers/Bills as presented and prepaid vouchers.

**SECONDED** by Commissioner Meyer. All were in Favor and **MOTION CARRIED.**

**MOTIONED** by Chairman Peters to approve the transfer of \$51,836.83 from the O&M Acct. ending in 0300 to Checking Acct. ending in 0190 to pay December 2022 Vouchers. **SECONDED** by Commissioner Burweger, all were in favor, **MOTION CARRIED.**

**MOTIONED** by Chairman Peters to approve the transfer of \$4,950.00 from Capital Acct. ending in 0000 to Checking Acct. ending in 0190 to pay LaBella Associates Voucher for I&I Study. **SECONDED** by Commissioner Burweger, all were in favor, **MOTION CARRIED.**

**MOTIONED** by Chairman Peter to approve payment in the amount of \$2,720.00 from Project No. 2 WWTP Acct. ending in 0500 to pay LaBella Associates Voucher for Septage Receiving Project. **SECONDED** by Commissioner Taylor, all were in favor, **MOTION CARRIED.**

**MOTIONED** by Chairman Peters to move \$5,317.92 from EFC Ban Line # 89892.5 to Maintenance & Repair Line # 13043.2. **SECONDED** by Commissioner Burweger, all were in favor, **MOTION CARRIED.**

**MOTIONED** by Chairman Peters to move \$38.05 from EFC Ban Line # 89892.5 to Equipment Line # 81104.7. **SECONDED** by Commissioner Burweger, all were in favor, **MOTION CARRIED.**

**MOTIONED** by Chairman Peters to approve purchase of Rotary Lobe Pump Rebuild Parts in the amount of \$4,735.52. **SECONDED** by Commissioner Locascio, all were in favor, **MOTION CARRIED**.

**RESOLUTION OF THE PAWLING JOINT SEWER COMMISSION**

***Identifier: Resolution regarding an electricity supply agreement with Constellation NewEnergy, Inc. for electricity provider services***

The following Resolution was proposed by Chairman Peters who moved its adoption, and seconded by Commissioner Tom Meyer.

**WHEREAS**, the Pawling Joint Sewer Commission desires to reduce its electricity costs to the maximum extent practical;

**WHEREAS**, the Pawling Joint Sewer Commission has identified Kevin Hamilton of NuEnergen as a person with specialized professional expertise in identifying companies who can offer the Sewer Commission the opportunity to enter into a variable rate contract with the option to lock in its electricity supply cost per kilowatts/hour for one or more fixed time periods during the term of the agreement;

**WHEREAS**, Kevin Hamilton has explored various companies that might be able to offer the Pawling Joint Sewer Commission such an opportunity and has recommended that the Sewer Commission enter into a contract with Constellation NewEnergy, Inc. in the form attached to and made a part hereof ("Constellation Agreement");

**WHEREAS**, in accord with the Pawling Joint Sewer Commission procurement policies, the Sewer Commission has determined that soliciting alternative proposals and quotations through another consultant or electricity provider would not be in the best

interest of the Sewer Commission because the subject services require special skill, training and experience and, in this regard, Mr. Hamilton is known for his accountability, reliability, responsibility, skill, training, and judgment, qualities which are not necessarily found in the individual or company offering the lowest price in the provision of electricity.

**NOW THEREFORE, BE IT RESOLVED** as follows:

- (i) The Pawling Joint Sewer Commission approves the Constellation Agreement in the form attached to this resolution;
- (ii) Chairman Peters is authorized to finalize negotiations of the Constellation Agreement (including any changes to the Constellation Agreement that he deems are beneficial or advantageous to the Commission), to execute the final version of such Constellation Agreement on behalf of the Commission and to take such other actions as he deems convenient, necessary or advisable in order to effectuate the execution of the Constellation Agreement by both parties.
